Invitation to Training on the Use of the Integrated Domestic Revenue Administration System (IDRAS) – Registration of Motor Vehicles and Issuance of Driver's Licenses

Dar es Salaam, February 4 2025

As part of efforts to enhance service delivery for taxpayers and the public at large, Tanzania Revenue Authority (TRA) is in the process of developing upgraded domestic revenue administration system known as **IDRAS**. The system will be implemented in phases, with the first phase officially launching on **10th February 2025** with the following modules:

1. Registration and Management of Motor Vehicles (cars, motorcycles, trailers, etc.)
2. Issuance of Driver's License

TRA has organized training sessions to taxpayers and other stakeholders for awareness on the improvements made and guidance on using the system effectively to improve efficiency in the specified areas.
